The [Global Partnership for Education](#) Secretariat is hosted by the World Bank Group. This Privacy Notice applies to the personal data the Global Partnership for Education collects and handles when hiring interns for the Inclusive Internship program.

The Global Partnership for Education processes data in accordance with the [World Bank Group Policy Personal Data Privacy](#).

#### **INFORMATION WE COLLECT**

We collect the following information when we hire interns for the Global Partnership for Education's Inclusive Internship program:

##### **Information You Provide to Us**

Global Partnership for Education may request your personal data, including: your name, email address, telephone number, resume or curriculum vitae (CV), level of education, work experience, language(s), certifications, and references. Candidates may be requested to provide additional information, such as passport number and proof of education degrees and work experience.

#### **INFORMATION WE SHARE**

Global Partnership for Education does not sell or otherwise share your personal data collected for this program, except as described in this Privacy Notice. We may share your personal data with third-party service providers who perform services related to the internship process, for example in order to facilitate information technology systems induction. Our service providers are not authorized by the Global Partnership for Education to use or disclose your personal data, except as necessary to perform services on our behalf. We require our service providers to appropriately safeguard the privacy and security of personal data they process on our behalf.

The Global Partnership for Education also may disclose personal data about you (i) if required to do so by law or legal process; (ii) for the purposes of, or in connection with, legal proceedings, or otherwise for the purposes of establishing, exercising, or defending any legal rights; (iii) in response to a request by law enforcement authorities; or (iv) when the Global Partnership for Education believes disclosure is necessary or appropriate to prevent physical harm or financial loss, or in connection with an investigation of suspected or actual illegal activity.

Your personal data may be shared with the World Bank Group's Human Resources department. The World Bank Group may also share your resume internally at the World Bank Group for other potential

employment opportunities. If you do not wish to be considered for other employment opportunities, please indicate this when you initially share your information with us.
